It has been resolved in the meeting of extended Admission Committee for Under-Graduate Studies of Bankura University along with Principals/OICs/TICs of the affiliated colleges under Bankura University on 29th August 2024 that guidelines for implementation/execution related to the admission in Under-Graduate programmes for the academic year of 2024-25 in standalone mode to fill up the vacant seats (if any) in pursuance of the notification issued by the Government of West Bengal (vide N.o.554- Edn(CS)/10M-95/14, dated 21st August 2024), are as follows:

Curriculum and Credit Framework for Undergraduate Programme (CCFUP):

1. New Curriculum and Credit Framework for Undergraduate Programme, UGC 2022 (as per NEP 2020) for 4-years undergraduate programme(s) with "UG Degree Programmes with Single Major" only will be maintained for the academic session 2024-2025.

Procedure of Admission:

- 1. Necessary advertisement for on-line admission to the Undergraduate (UG) Programme for the academic year 2024-2025 will be made by the respective undergraduate colleges of their own (Standalone mode) as per the notification issued by the Government of West Bengal (vide N.o.554- Edn(CS)/10M-95/14, dated 21st August 2024). Online admission be completed by 30/09/2024 positively. The colleges will provide all the information related to the admission for Undergraduate Programme along with a helpline desk (time specific) through mobile/email in their website in this regard.
- 2. The entire admission process should be made online, strictly based on merit. Prospective students should not be called for counseling or verification of documents during the process of

- 3. Documents to be uploaded (not limited to) by the students while filling up the online application:
 - Admit card and Mark-sheet of Madhyamik Examination.
 - Mark-sheet of Higher Secondary Examination.
 - Caste Certificate (where necessary).
 - PH Certificate (where necessary).
 - EWS Certificate (where necessary).
- 4. Verification of the documents should be done only when the students report for the classes in due course by the college. Admission will be cancelled if the documents are found not in conformity with the declaration in the forms submitted online or any stage /time of the admission process.
- 5. All orders, notifications/Extant Rules//modalities issued by the Government of West Bengal including the notification (vide N.o.554- Edn(CS)/10M-95/14, dated 21st August 2024) are applicable and to be complied in the matters of admission and reservation rules.
- 6. All other directives/ rules / guidelines/modalities related to the admission in Under-Graduate programmes for the Academic Year: 2024-25 as approved in the meeting of Faculty Council for Under-Graduate Studies dated -28.03.2024 and circulated accordingly (vide Ref. No: BKU/FCUG/52/2024 dated: 02/04/2024) will remain the same and applicable where required.
- 7. The admission in different Undergraduate programmes in Santali Vernacular under the Aegis of Centre for Studies in Santali Culture and Language, Bankura University may be conducted by the University, standalone mode to fill up the vacant seats (if any).
- 8. In case of any discrepancy the decision of the appropriate authority of the university shall be final.
